Text composition price is based on using a four color standard design, 7 x 10 trim, text provided on disk as well as hardcopy, and approximately 32 pages. Since we cannot determine the exact final page count at this time we have used an approximate page count to determine cost. **Final cost will be based on the actual final page count.** Per page prices have been listed below for that reason. **Any changes to design or text content once the book is typeset into first proofs are not included in above prices and will be charged at the appropriate price as stated below.**

Cover price is based on creating a four-color cover with 7 x 10 trim, creating bar code, scanning one piece of color art, and all other images provided electronically according to specifications outlined at www.bookmasters.com. The design will be based on customer-provided information on our cover design questionnaire. If actual design differs from information provided, this estimate will need to be revised.
